# Powerschool Breach

Breach affected all school district who use Powerschool as their Student Information System (SIS)

- Investigating the incident
- No social security numbers are housed in PS
- Working with our legal counsel and cybersecurity provider to monitor the situation.
- Full report of incident from PS will be shared with the district
- Additional information will be shared with families and staff when available



# Proposed Summer School Plan

June 9–30: Summer School (no school on June 19th)

June 6: teacher planning day



March 3 :Summer School booklet and open registration

- Cost: \$150 per child (15 days = \$10 per day) – must be paid (checks only) to be registered
- A limited number of students who are recommended to attend will receive a tuition voucher

March 11 and March 13: parents receive voucher at conferences

April 25: close registration – payment must be made

# Proposed Fees

## **Tuition:**

Preschool: \$3,000 (if not covered under the PFA grant)

Kindergarten: \$3,000 for full day

## **Technology/Curriculum Fees:**

Preschool: \$180 (if not covered under the PFA grant)

Kindergarten–8th grade: \$275

## **Comparisons:**

Park Ridge: K–5: \$227, 6–8: \$315

Union Ridge: \$255

Pennoyer: \$285

St. Eugene: \$650

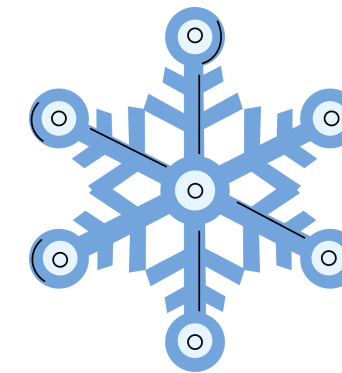

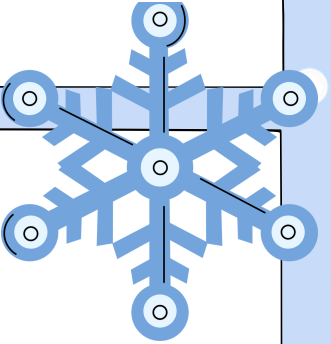
4:11 Annual Budget: clean up spaces

# Policy Update



## Policy 4:175

Screening: The Superintendent or designee shall perform fingerprint-based criminal history records information checks and/or screenings required by State law or Board policy for employees; student teachers; students doing field or clinical experience other than student teaching; contractors' employees who have direct, daily contact with one or more children; and resource persons and volunteers. The Board President shall ensure that these checks are completed for the Superintendent. He or she shall take appropriate action based on the result of any criminal background check and/or screen.



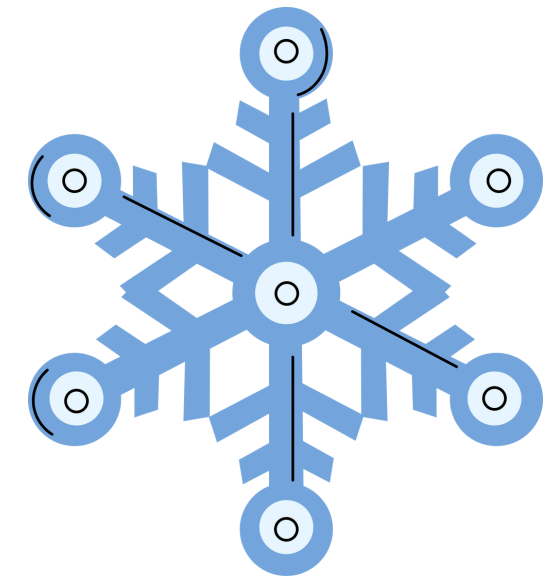

District 80 received final approval for the Giles Infrastructure Grant

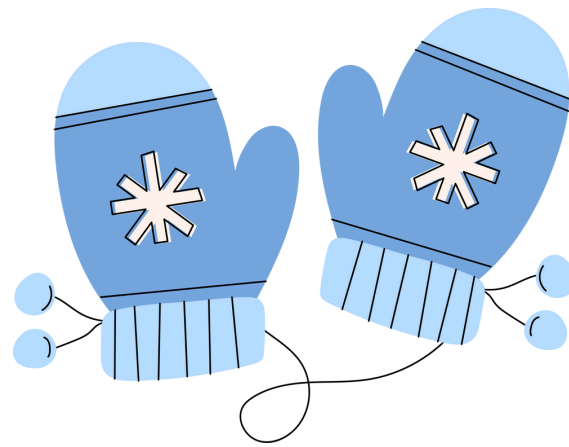
- \$175,000

happens next

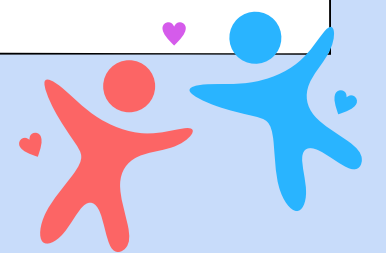
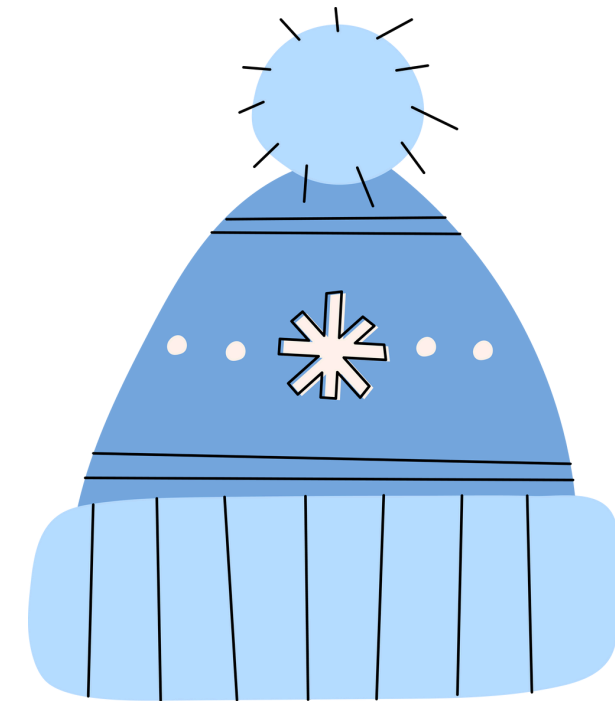


# Follow-up and Future
