





POLICY CHANGES

PA 104-32 - New law requires districts to offer age appropriate Mental Health Screenings to Students in grades 3-8 beginning with the 2027-2028 school year families can opt out of screening.

P.A. 104-20 - eliminates the requirement for evaluations to consider growth as a significant factor. This must to be negotiated with NEAT to make any changes to our current plan.


