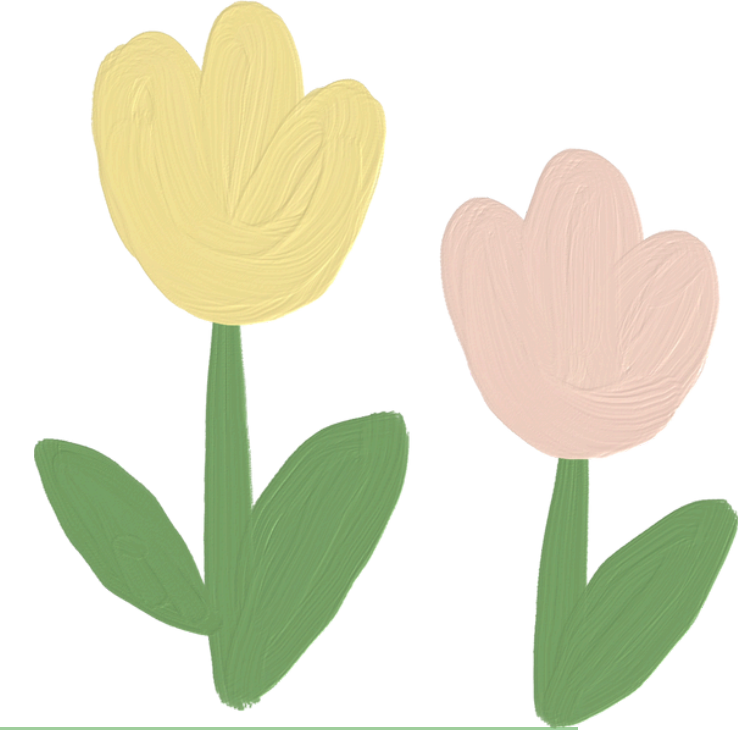

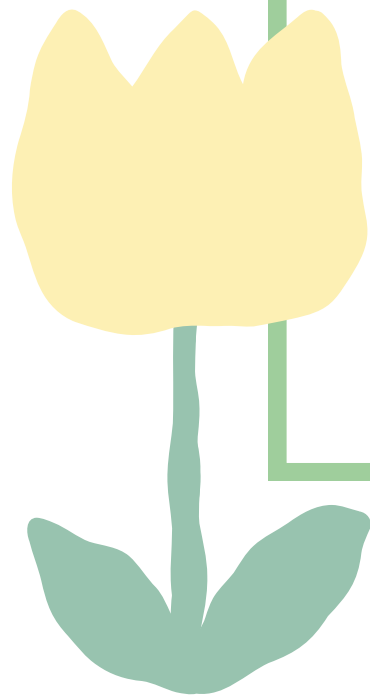
Giles Infrastructure Grant

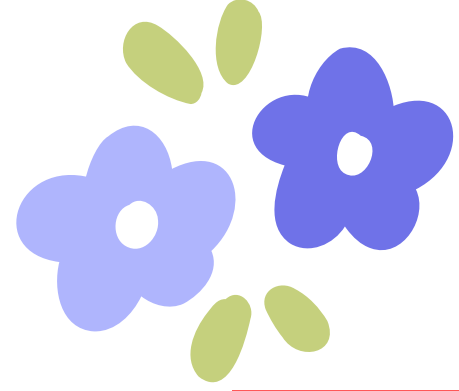

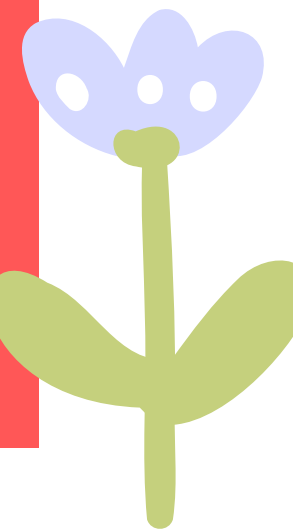
